Lethbridge County & local area residents flown by STARS (2010-Present)





Members of Council,

Please accept this Report of some of the March activities of the CAO, as well as an update on several Council directives.

New CAO Shawn Patience

While the role of an Interim CAO is to provide stability, the underlying uncertainty of "who will be the new CAO" has lingered through this transition, so the announcement of Shawn Patience as our new CAO has been welcome news to staff. They have been incredibly patient through the hiring process waiting for this news and are excited to move into the next chapter.

Shawn was in the office on March 24th to meet (most of) the office staff. He hopes to be in once or twice more before his official start date, in May. He and I communicate regularly, and I am ensuring that he is informed and invited for feedback on the significant financial and HR matters.

Community Safety Meeting

Thank you to the Member of the Coaldale RCMP Detachment for taking the time to prepare and present to our community. We had a good turnout with great questions following the presentation. The main takeaways of the evening were that Coalhurst is a safe community and that we all play a role in ensuring that crime – mainly theft and drugs - doesn't take root in our community.

One comment resonated with me: "When people experience crime, they go onto Facebook and complain about it." That's understandable: Facebook is a great place to vent! However, the RCMP respond to communities based on statistics and if you don't report a crime – no matter how insignificant it may seem to you – officers can't track trends, follow criminal activity or pursue the criminals with known behaviours and patterns of operating.

If you have experienced crime, call the RCMP information line to report it *first*, before you go onto Facebook. Let's give the police the information they need to solve crimes and prevent further criminal activity in Coalhurst!

Of course, if you see a crime in progress, call 911.

Public Open House – The Wetlands

We had a good turnout for Council's Public Open House around The Wetlands. Those who stopped in provided great information and feedback. Additionally, we have had a great response to the online survey, again with excellent and valuable feedback. The online survey closed on April 1st and the CAO or Designate will provide the survey results to Council at the April 18th Regular Meeting.

Street Sweeping

The Town will be sweeping streets on April 6th and 7th, depending on the weather. If possible, we encourage residents to move their vehicles from the streets on the 6th and 7th to facilitate a good cleaning of our streets and gutters.

Hiring

Advertising for the positions of Coordinator of Community Development and Development Officer respectively, was extended so that the new CAO can review the applications and participate in the interview process. The Coordinator posting closed on March 31st while the Development Officer posting will close on April 14th.

2022/23 Fire Services Traininig Program Grant

March was a good month for grant notices! On top of the previously announced ACP grants, the Town has been approved for a Fire Services Training Grant. This grant will offset firefighter costs associated with NFPA 1001 Level 1, NFPA 1031 Fire Inspector Levels 1 & 2, and NFPA 1072 Hazmat training sessions. This will support our Fire Department with increased knowledge and practical applications that will service Coalhurst (and area) residents and businesses.

Council Direction Updates

There are four outstanding Council directives on which I can provide some feedback.

CAPTURE Program:

M# 7363-23 (Feb 7, 2023) Cllr Akkermans MOVED that Council instruct the CAO to investigate establishing a CAPTURE program in Coalhurst, with consideration for involving neighbouring municipalities in the project. Carried

Cst Marentette (Coaldale RCMP) reached out to advise me that he is working on getting Coalhurst added to the current system of cameras. He is hoping to have more information by the end of April.

Defining Anti-Semitism:

M#7250-22 (October 18, 2022) Councillor Florence moved that Council instruct the CAO to bring forward proposed amendments to applicable bylaws and policies that would include the definition of "Anti-Semitism", as suggested by the Minister of Justice. Carried

The CAO has not taken any action on this Motion as a full review of the Town's bylaws and policies is required to assess the applicable placement of a statement on Anti-Semitism. The Coordinator of Legislative Services is undertaking a process evaluation to determine the best approach for the Policy Bylaw Risk Review Committee to review Town bylaws and policies. Through that review process, a proper assessment can be undertaken to determine the most appropriate place to express this statement.

Neighbourhood Play Program – Review and Analysis

INQUIRY

What is the impact that Barons-Eurika-Warner Family & Community Support Services (BEW-FCSS) 2023 Municipal Requisition 2% per capita increase, will have on the Town of Coalhurst's budget.

BACKGROUND

At the March 21, 2023 regular Meeting of Council, we received a correspondence letter from BEW FCSS, informing Council Members of the board approved 2% per capita increase in the municipal requisitions for BEW FCSS. Questions were raised about the budget impact and when this would take effect.

ADMINISTRATIVE RESPONSE

In November 2022, the BEW-FCSS Board of Directors approved unanimously a 2% increase to municipal requisitions. FCSS continues to see an increased need for supports from residents, so to address the rising need – and associated costs – the Board proposed a 2% increase to the requisition. Member municipalities had to vote on the increase, which was approved.

BEW-FCSS bases their requisition amounts on population data, provided by the Government of Alberta. For the last several years, the province established Coalhurst's population at 2784.

The 2023 Annual Funding Contribution for FCSS is \$22,272.00. This is a 2% increase of over the 2022 requisition (\$21,826.56).

The impact of this increase is an additional budget pressure of \$445.44. However, this cost can be absorbed within the current budget estimates and through efficiencies created by the Director of Corporate Services.

Dear Minister Savage,

On March 14, Council heard from Evan Jamieson, President, Alberta Weekly Newspapers Association. Mr. Jamieson highlighted what impact changes to the EPR program would have on newspaper media.

The newspaper industry is already under extreme financial pressure due to increased costs of materials and inflation coupled with the decline in advertising spend and subscriptions. It might seem simple to discontinue physical publications in a digital world; however, digital excludes entire demographics of individuals who cannot access the internet. Newspapers serve as a source of information for those who still operate in an analogue world. A newspaper shuttering its doors due to additional expenses, will cut an entire demographic off from access to local, national, and international news.

We urge the UPC to follow in the footsteps of jurisdictions such as Great Britain and Ontario where newspapers have become exempt from similar EPR programs. Newspapers have multiple uses, offering a secondary purpose aside from providing information about the world. Among other uses, they are conducive as insulation for temperature sensitive products during transport and protect precious family heirlooms during a move. We urge you to recognize the importance of local papers and the impact the potential closure newspaper businesses would have on the social fabric of the communities they serve. Consider the challenges already faced. Follow in the footsteps of the Ontario government, and please exempt newspapers from the revised EPR program.

Dear Chief Elected Official:

Joint use and planning agreements (JUPAs) between municipalities and school boards operating within municipal boundaries enable the integrated and long-term planning and use of school sites on municipal reserve, school reserve, and municipal and school reserve lands.

On June 10, 2020, Section 670.1 of the *Municipal Government Act* was proclaimed, setting the deadline for municipalities to complete these agreements with the applicable school boards by June 10, 2023.

The ministries of Municipal Affairs and Education have heard from municipalities and school boards about the challenges of meeting this deadline. My colleague, the Honourable Adriana LaGrange, Minister of Education, and I have agreed to extend the deadline for municipalities and school boards to June 10, 2025, to provide sufficient time to complete these agreements.

In addition to this extension granted as per Ministerial Order No. MSD:013/23, the Ministry of Municipal Affairs can provide additional supports to municipalities to assist with the development of these agreements.
