BYLAW NO. 449-23 A BYLAW OF THE TOWN OF COALHURST IN THE PROVINCE OF ALBERTA "2024 FEES & RATES BYLAW"

WHEREAS the Municipal Government Act provides that Council may pass a bylaw respecting the fees and rates a municipality may charge for services rendered;

AND WHEREAS the *Freedom of Information and Protection of Privacy Act*, as amended, states that a municipality must make certain information available to the public and that the Council may pass a bylaw to establish fees for the provision of such information;

AND WHEREAS the Council of the Town of Coalhurst, in the Province of Alberta deems it expedient to consolidate the fees, rates, and charges for various municipal services;

NOW, THEREFORE, the Council of the Town of Coalhurst, in the Province of Alberta, duly assembled, enacts as follows:

1.0 TITLE

1.1 This Bylaw may be cited as the "2024 Fees & Rates Bylaw".

2.0 DEFINITIONS

- 2.1 In this Bylaw:
 - 2.1.1 **Act** or **MGA** means the *Municipal Government Act*, R.S.A. 2000, c. M-26, and associated regulations, as amended;
 - 2.1.2 Administration means the administrative and operational arm of the Municipality, comprised of the various departments and includes all employees who operate under the leadership and supervision of the CAO;
 - 2.1.3 **Chief Administrative Officer (CAO)** means the person appointed to the position in accordance with the MGA.
 - 2.1.4 Council means the Council of the Town of Coalhurst;
 - 2.1.5 **Session** means a four-hour block of time
 - 2.1.6 **Town** means the Town of Coalhurst

3.0 GUIDELINES

3.1 The fees, rates, and charges payable for municipal services provided by the Town are outlined in Schedule A, which is attached to and forms part of this Bylaw. Such fees may



be subject to GST.

- 3.2 The rates specified in Schedule A, which is attached to this Bylaw, may be amended from time to time upon the recommendation of the CAO and shall be approved by a Bylaw of Council.
- 3.3 Council may consider setting or permitting special rates for special circumstances, special items, or individual agreements with outside parties for any items not covered in Schedule A by way of Council resolution.
- 3.4 In the event this Bylaw conflicts with another existing Bylaw or Policy, this Bylaw shall take precedence.
- 3.5 This Bylaw and Schedule A will be reviewed for amendments annually by Administration as well as Council.

SEVERABILITY 4.0

4.1. If any clause in this bylaw is found to be invalid, it shall be severed from the remainder of the bylaw and shall not invalidate the whole bylaw.

5.0 REPEAL
